- 1) IMAGE SPORT WILL SET UP A HYPERLINK THAT DIRECTS CUSTOMERS TO THE PRODUCT PAGE OF MY SPORT, ORGANIZATION, OR CLUB. THEY WILL ALSO PROVIDE ME WITH AN EXCLUSIVE DISCOUNT CODE FOR MY PARTICIPANTS TO USE AT CHECKOUT.
- 2) IMAGE SPORT WILL PROVIDE MARKETING SUGGESTIONS AS WELL AS SAMPLE EMAILS, TEXTS, FLYERS, AND SOCIAL MEDIA POSTS.
- 3) MY COMMISSION AND MY CUSTOMER'S DISCOUNT WILL EQUAL 25% OF THE TOTAL SALES (EXAMPLE: 15% CUSTOMER DISCOUNT, 10% COMMISSION).
